# School Board Goals 2014-2015

#### I. STUDENT ACHIEVEMENT

Goal: Increase achievement and growth for all students.

During the 2014-2015 school year:

- Delta County School District will meet or exceed state averages on state assessments.
- 100% of the core teachers will be following the pacing guides of the District curriculum, teaching the priority outcomes for each unit.
- Delta County School District will continue to implement the Colorado Academic Standards as the baseline giving our teachers local control on how to best exceed standards in all areas of the curriculum.
- the Board will continue to oversee the development and research of a comprehensive K-12 math curriculum.

#### II. STAFF CAPACITY BUILDING

Goal: Build our staff confidence and ability to perform at a high level.

During the 2014-2015 school year:

- the Board will continue to support and provide the necessary tools for staff to ensure a 21st century education for all students.
- the Board will encourage the Superintendent to continue to find ways to increase staff morale and appreciation through resources and communication.
- the Board will ensure that adequate professional development is provided for all instructional staff.

#### III. STEWARDSHIP OF DISTRICT RESOURCES

Goal: Provide prudent stewardship of district resources to best support student success.

During the 2014-2015 school year:

• the District will continue to maintain a fund balance of 10% with the goal of increasing fund balance while maintaining a balanced budget.

- the District will ensure financial transparency through the building level by posting financial information on-line, in a downloadable format, for free public access.
- the Board will continue to review, update and monitor implementation of School District policies by the Superintendent.
- the Board will continue to monitor Class Size Guidelines that were developed in the spring of 2014 based on the enrollment numbers.
- \* the Board will oversee a re-structuring of the transportation department and the replacement of fleet vehicles, and a 1-3 year plan in the areas of finance, capital, and the Technical College.
